

## DIRECTIONS TO TRIAL SITE

From North/South: US 131 Take exit 101 (M57). East 1 mile to Northland Drive. Go north 0.6 miles to Cornfield Drive on west side of road.  
From North Beltline: Go north past Rockford. Site is 0.6 miles north of M-57.  
Note: The Beltline changes names ( Northland Drive, Wolverine Blvd., back to Northland Drive again. Just stay on the main road).

The **Obedience Trials will be held consecutively** so there can be no same day move ups.

**Rally move ups** must be submitted to the Secretary 30 minutes prior to start of Rally Trial 2.

*General Information:*

Building will be open at 7:30am both days. Help with set up and take down will be appreciated.
